## 2018 UEC Ordinary General Assembly

Dear Presidents,

Further to our correspondence of 6 November 2017, taking into consideration the election of Mr David Lappartient as UCI President, we would like to explain the various electoral procedures planned at the next 2018 UEC Congress in accordance with the UEC Constitution:

## Article 10

The Management Committee

- 1. The Management Committee is composed of:
  - a) the President,
  - b) three (3) Vice-Presidents,
  - c) three (3) other members.
- 4. In the event of any vacancies, the Management Committee will remain validly constituted and the vacant posts shall be filled at the next General Assembly. When the post of President is vacant, the measures of article 12.6 and 12.7 shall apply.

#### Article 12 The President

7. Should the post of President become permanently vacant, he/she shall be replaced until the next General Assembly by a Management Committee member it has elected. At the following General Assembly and after finalising the Management Committee, the permanent replacement of the President shall be decided for the duration of the remaining term of office. Only Management Committee members – including the newly elected member – may apply for the post.



In accordance with the UEC Constitution, the UEC Management Board is proposing for the elections to be carried out as follows:

1. Election of one (1) Member of the UEC Management Committee

Note: in accordance with Article 13 – points 2 and 4

The candidates for the position of UEC Management Committee Member must be proposed by the federation of the nationality of the candidate or, provided they have the nationality of a UEC member federation, by that which issued his/her licence.

It is possible to be a candidate in several elections provided that the conditions pertaining to each of them are adhered to.

### 2. Election of the UEC President

Only Management Committee members – including the newly elected member – may apply for the post.

Note: in accordance with the article 13 – point 3

The following may apply for the post of UEC President:

- Anyone whose application is put forward by the federation of the candidate's nationality or, provided they have the nationality of an UEC member federation, by that which issued his/her licence;
- Individuals whose application has been put forward by at least 3 UEC member federations, provided that they have the nationality of a UEC member federation.

The applications must be sent to the UEC headquarters, addressed to the electoral and voting monitoring commission (CCOEV), by post or e-mail, at least thirty days before the General Assembly.
